Subject: Uploading of pending data on RCCS portal and its authentication thereof.

Order: 109/FC/Adm of 2022 Dated: 09.06.2022

While reviewing the status of updation of manual data of court cases being shifted on RCCS portal by the Revenue Courts in the districts, instances have been observed that despite repeated instructions, the updation of requisite information viz., Court Cases diary/proceedings updation, uploading of final Order sheet/decision of the Courts is pending at various Revenue Courts levels, which has been viewed seriously by the Higher Authorities.

Accordingly, In order to expedite the updation of pending data on RCCS portal, the Tehsildar Headquarters (HQA) and Assistant Revenue Attorney in the District shall make 100% verification and authenticate the data updation of Revenue Courts in districts. They shall liaise with the readers of various courts in the district and obtain a certificate from the Presiding Officer concerned thereupon. The Deputy Commissioner shall furnish a certificate to the effect, In respect of District, that the requisite data, especially the court case diary/proceedings/legacy data and the Order sheets of the decisions of the court have been updated on the RCCS portal. The Deputy Commissioners may carry out random checks before furnishing such certificates. Once the updation is done by 15th of June, the HQA & ARA shall ensure through random checks that all the presiding officers in the districts are uploading the data on daily basis . They shall also maintain a log of the checks made.

Further, the Presiding Officers of the following courts, other than those in the districts I.e. (a) Divisional Commissioner, Kashmir/Jammu (b) Commissioner, Survey & Land Records, J&K (c) Oustodian General, J&K (d) Regional Director, Survey & Land Records(All) (e) Additional Commissioners with Divisional Commissioner Kashmir/ Jammu (f) Custodian Evacuee Property, Jammu/Kashmir (g) Provincial Rehabilitation Officer, Jammu shall also submit a similar certificate as mentioned above.

The process for uploading legacy data on RCCS by all courts and to begin with cases decided since the year 2015 is to be completed by 30th June, 2022. Thereafter, the legacy data for the previous years to be taken up and completed within 02 months.

Besides above, the following officers are deputed to the districts given below to supervise and check the uploading of court cases data on RCCS portal and shall submit their report by 17.06.2022:-
