Subject: Disposal of pending cases under repealed Acts in the Revenue Courts.

In exercise of the powers vested under section 140 (4) of the Land Revenue Act and as per the recommendations so made by the Board of Revenue, which took note of the commencement of physical hearing after Covid-19 in the courts, the Presiding Officers of the Revenue Courts where the cases under Acts repealed vide SO.3808E Dated 26.10.2020 are pending adjudication, are delegated powers to adjudicate upon the same on fast track basis. The Presiding Officers shall ensure that while disposing of the cases, the instructions contained in section 140 (3) are also referred to and the parties are summoned through electronic mode i.e. RCCMS in addition to the procedure already in vogue, no adjournments of more than 15 days are granted and the cases are decided within three months.
